BIKE 31: One and Done SAFETY STATEMENT

The members of Bike Michiana Coalition and Visit South Bend Mishawaka are concerned about the safety of the cyclists participating in the event. Although an accident-free day of enjoyable cycling is our prime goal, the impressions that we leave with others, particularly motorists, are important to the future of Bike Michiana Coalition, as well as the acceptance of bicycling by the general public as a legitimate form of transportation and recreation.

◆ ◆ ◆ HELMETS ARE REQUIRED ◆ ◆ ◆

- Ride in a straight line as far to the right as possible.
- Signal your intention to change lanes, slow down, or stop.
- If you are preparing to pass other cyclists, warn them by calling, "On your left (right)."
- When you stop for repairs or to rest, get completely off the roadway.

INDOT Safety Statement

In consideration of the Indiana Department of Transportation (INDOT) granting permitting the Bike Michiana Coalition and Visit South Bend Mishawaka to use portions of the New U.S. 31 (under INDOT Permit ____). I, on behalf of myself and my guardians, heirs, representatives, successors and assigns (if any), do hereby release, waive, and covenant not to sue the State of Indiana and all of its agencies, officials and employees (including INDOT, collectively the "Released Parties"), from any and all liability and claims for injury, damage, loss or expense arising out of my entry onto and activities on any INDOT property or facilities (including associated right-of-way or structures), including without limitation any act, or failure to act, by the Released Parties. I understand the inherent dangers associated with accompanying agents or employees of INDOT and entering onto the INDOT facilities and surrounding areas and waiver any and all specific notice of the existence of such dangers.
